Rental Agreement

THIS AGREEMENT is entered into by and between Indigo Charters LLC and

1. Indigo Charters LLC will provide the services to the RENTER listed in Appendix A.
2. RENTER agrees to the services listed in Appendix B.
3. RENTER agrees to the terms and conditions listed below.

* Hourly rates apply from the time the bus departs our shop until the time bus returns to our shop.

* Additional charges will apply based on the Hourly Bus.

Renter Agreement

By signing this agreement, we agree that no alcohol of any kind will be consumed on the vehicle rented. Alcohol may only be transported in sealed and closed container. Violation of this will result in termination of the agreement and forfeit of all payments.

We agree that we will not hold the driver or the owner responsible for any accidents or injuries incurred through the improper use of the equipment. We have entered and ridden this bus at our own risk, and will not hold them responsible for our own actions while on the bus.

Terms and Conditions

Renter Eligibility

Renter must be 21 years of age or older.

Renter Responsibility

The renter is responsible for all activities of the passengers on board the bus.

Bus Deposit

A 25% deposit per contract is required.

A deposit must be received within five business days of making your reservation or the reservation will be considered canceled.

Any deposit made less than two weeks prior to the event date must be made in credit card only.

If the agreement is canceled within 14 business days you will receive a full refund. If the agreement is canceled with less than 14 business days left you will forfeit the deposit amount.

Deposit refunds will be made via credit card refund within 14 days.

If there is any damage to the bus or excessive cleanup is required, a damage assessment will be made and extra charges may apply. Any damage assessment will be determined once the bus has returned to the shop and has been thoroughly cleaned.

Payment

Full payment in (cash or credit) only must be received with 48 hours of the charter start date.

Alcohol Policy

Alcoholic beverages are not permitted.

Non-alcoholic beverages

Cans and plastic containers are permitted. Please try not to bring glass bottles for safety reasons.

Smoking Policy

No smoking on any Indigo Charters LLC vehicles.

Rules of Conduct

No fighting will be tolerated. Violation will result in the immediate termination of the bus run. No refunds. No exceptions.

No weapons. Violation will result in the immediate termination of the bus run. No refunds. No exceptions.

No illegal drugs. Violation will result in the immediate termination of the bus run. No refunds. No exceptions.

Relationship

Indigo Charters LLC and RENTER intend that their relationship at all times and for all purposes under this Agreement be independent. Neither party is to be considered an agent or employee of the other party for any purpose.

Excuses for nonperformance

Neither party shall be held in default for delay or failure to perform caused by unforeseeable events which are beyond the control of the party and which are substantially of the following nature: labor dispute, acts of God, legal acts of public entities.

Indemnity

RENTER shall save, defend, indemnify, and hold harmless Indigo Charters LLC, and its officers, agents, employees, from all claims, suits, and actions of whatsoever nature resulting from or arising out of the activities of RENTER or its subcontractors, agents, or employees acting under this Agreement.

Insurance

Indigo Charters LLC in insured to at least the minimum set fourth by FMCSA. Proof of insurance provided upon request.
